10.2. Receive and Adopt Fire Facility Fee Technical Report

Joe Colgan of NBS presented the Fire Facility Fee Technical Report. The District hired NBS to come in and do a technical report to look at all new building coming in within the City of Lathrop. Joe Colgan went over the legal rules that must be followed when assessing the proposed fire facility fees and explained the reasonable relationship between the project and the fees. He also went over the formula of how they calculated the fees to accurately covered the impact. Through their research and calculations, NBS recommend increasing the Fire Facility Fee to .53 cents per square foot for both residential and

commercial. Director Ishihara had questioned what the current Fire Facility Fee is and Chief Neely answered .31 cents per square foot for residential and .43 cents per square foot for commercial. Director Rhodes and Director Coe had concerns regarding Station 32 and Station 33 being left out of the analysis, but Chief Neely and Mr. Colgan assured them that by there was very little impact to the number by leaving the two stations out but if development starts to happen in those areas of our District, we could reevaluate and potentially adopt new fees. Director Coe questioned the fees of neighboring District's and Departments however, other Districts and City Departments collect their fees in different ways. Chief Neely told the Board that this report would have to be presented at the City Council meeting and in the near future, he will be bringing a Resolution for the Board to adopt.

Director Coe made a motion to Receive and Adopt the Fire Facility Fee Technical Report.

12. BOARD COMMENTS / REFERRALS

Director Rhodes: Commented that while out at the conference in Napa, she met a Fire Chief from a small Fire District in the Northern part of the State. Vice Chair Elliott: Stated he and his wife enjoyed working at the fireworks booth and it was great to see the amount sold. He thanked everyone for their work.

Director Ishihara: Thanked Hailey for driving him and Gloryanna to the conference. He also thanked Rozelle and Debbie for their work at the Fireworks booth. He stated that he and Bennie were at the booth almost every day. He also requested that the Chief Isham relay a thank you to the ones who were on duty, got off, and went and worked the fireworks booth. Director Ishihara also made comments about Behind the Fire and how he thinks it is great for the spouses and family. Director Ishihara ended with a thank you to the Firefighters for their help at the Breakfast at the Senior Center.

Director Coe: Questioned if there is any new news regarding the potential PG&E outages and made reference to a newspaper article stating the projected cost of the outage per day for the city and the District. Chief Neely commented that he felt the city has prepared and feels that our position in the flood zone potentially played a factor in the good planning. However, for all of the generators to operate they are projecting to use about 10,000 gallons of gas per day. Director Coe also asked if there have been any updates on SB 438. Chief Neely updated that the bill has already passed the senate, local government committee and the health committee. He also stated that there have been some amendments made along the way, but now the bill is going to go in front of appropriations.

Chairman Gish: Stated that he is relocating out of the Lathrop – Manteca Fire District and will be resigning as Chairman from the Fire Board immediately after the meeting. He shared kind words regarding the work the Board has accomplished over the last 3 years. He expressed for the Fire Board to continue our mission and the LMFD will continue to be one of the best agencies in the area. He thanked the Chief, Administration Staff, and the Firefighters. He also thanked all of the residents, businesses and stakeholders for all of their support.

- The policy clearly outlines and designates which positions require disclosures.

- By implementing this policy, it will help maintain a uniform process of identifying individuals who must disclose and the documents required.

0.60 Conflict of Interest Policy

Lathrop Manteca Fire Protection District Conflict of Interest Code Disclosure Policy

PURPOSE

The purpose of this Conflict of Interest Code is to provide for the disclosure of assets, income and business positions of designated District officials and employees which may be materially affected by their official actions, so that the District and the public may be aware of potential conflicts of interest.

SCOPE

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to promulgate and adopt conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's conflict of interest code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act.

POLICY

Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference.

This regulation and attached Appendix 1 designating positions and establishing disclosure categories shall constitute the conflict of interest code of the Lathrop Manteca Fire Protection District (District).

Individuals holding designated positions shall file their statements of economic interests with the Secretary of the District, who shall be the official filing officer, and who will make the statements available for public inspection and reproduction (Gov. Code Sec. 81008). All statements will be retained by the District.

As provided in Government Code Section 82011, the code reviewing body is the San Joaquin County Board of Supervisors.

APPENDIX 1

LIST OF DESIGNATED OFFICIALS AND EMPLOYEES AND DISCLOSURE CATEGORIES FOR CONFLICT OF INTEREST CODE

Each person holding any position listed below must file statements disclosing the kinds of financial interest shown for the official's or employee's position. Statements must be filed at the times and on the forms prescribed by law. Failure to file statements on time may result in penalties including but not limited to fines.

DESCRIPTION OF DISCLOSURE CATEGORIES

Category 1. Investments

A designated official or employee assigned to Category 1 is required to disclose investments that may be materially affected by any decision made or participated in by the designated official or employee. The official or employee should complete the appropriate schedules of Form 700 for investments.

Category 2. Interests in Real Property

A designated official or employee assigned to Category 2 is required to disclose interests in real property that may be materially affected by any decision made or participated in by the designated official or employee. The official or employee should complete the appropriate schedule of Form 700 for interests in real property.

Category 3. Income

A designated official or employee assigned to Category 3 is required to disclose income that may be materially affected by any decision made or participated in by the designated official or employee. The official or employee should complete the appropriate schedules of Form 700 for income.

Category 4. Business Positions

A designated official or employee assigned to Category 4 is required to disclose any business entity in which the designated official or employee is a director, officer, partner, trustee, official or employee or holds any position of management that may be materially affected by any decision made or participated in by the designated official or employee. The employee should complete the appropriate schedules of Form 700 for business positions.
