## SFT Confined Space Rescue Technician

**Description:** The objectives of the course will start with providing fire service personnel with information on the regulations and standards regulating entry into confined spaces. Personnel will also be instructed on how to identify and distinguish both confined spaces and permit-required confined spaces.

With each of the two confined space categories differentiated, personnel will be able to identify the various hazards associated with confined spaces. Building upon this information, they will be provided with the knowledge, skills and abilities to perform confined space rescues. These include the selection and use of atmospheric monitoring equipment, hazard control equipment, personnel protective equipment and victim removal/packaging systems.

In order to apply the principles of confined space rescue, students will be presented with various scenarios in order to operate as rescue teams planning, constructing and commanding a confined space rescue incident.
